1 29 Repeal the ordinance heretofore passed which established 2 hour parking 9:00 A.M. to 4:00 P.M., All Days on Merrimac Avenue from Dickens to Palmer Street (2100 North);

ITEM WARD

AMEND RESIDENTIAL PERMIT PARKING ZONES:

2 3 Extend residential permit parking zone 898 to include the 1800 block of S. Dearborn (both sides);

3 25 Extend residential permit parking zone 605 to include S. Hoyne Avenue (west side) from 2300 to 2348 and (east side) from 2301 to 2341;

4 31 Amend ordinance passed May 9, 2007, page 105136 which established a residential permit parking zone 1347 on the 5500 block of W. Wellington Avenue (south side) from first alley east of N. Central Avenue to N. Luna Avenue, At All Times (Zone 1347) is amended by adding the following: (north side) from first alley east of N. Central Avenue to N. Luna Avenue;
