Consideration will be given to the following matters:

1. An Ordinance introduced by Aldermen Walter Burnett, Jr. and Emma Mitts authorizing the Commissioner of Fleet Management to donate two (2) obsolete ambulances to the city of Harare, Zimbabwe.
2. An Ordinance introduced by Alderman Isaac S. Carothers authorizing the Commissioner of Fleet Management to donate a Police Department Command Vehicle to the City of Berwyn, Illinois.
3. An Ordinance introduced by Alderman Edward M. Burke authorizing the Commissioner of Fleet Management to donate twelve obsolete items to the Fire Museum of Greater Chicago.
4. An Ordinance introduced by Alderman Manuel Flores authorizing the Commissioner of Fleet Management to donate one obsolete ambulances *respectively* to the National Counsel of Volunteer Firefighters located in La Piedad, Michoacan, and Ciudad Mendoza, Veracruz; also to donate one obsolete fire truck *respectively* to the Municipality Teloloapan, Guerrero Mexico, the National Counsel of Volunteer Firefighters (Academy of National Firefighters), and the Volunteer Firefighters of Jalpan de Serra Queretaro based in San Luis de la Paz, Guanajuato.
5. A Substitute Ordinance introduced by Alderman Robert Fioretti amending the Municipal Code of Chicago Section 11-12 adding new section 11-12-085: Theft of hydrant or parts thereof.
6. A hearing requested by a Resolution introduced by Alderman Isaac S. Carothers inviting individuals involved in the collective bargaining process for the Chicago Police Department to discuss the upcoming collective bargaining agreement.
