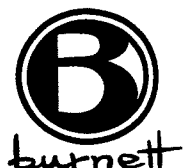

- 4 Waive the Itinerant Merchant License fee, Food Vendor License fee and all permits to the **African/Caribbean International Festival of Life** to be held at 55th Street and South Cottage Grove in Washington Park, July 3 -6th, 2008 from 10:00am to 10:00pm.
