<p><b>Suitable documentation:</b> To waive the late fee or to receive a prorated fee, only the date on the following documents can be used - lease, title/mortgage, dated vehicle registration, auto dealer bill of sale, vehicle title, IDOR vehicle tax forms.</p> <p><b>Late fee:</b> July 16th through May 31st a \$40 late fee applies unless the suitable documentation proves the applicant moved to Chicago or purchased the vehicle within the last 30 days.</p> <p><b>Fee:</b> The date on the suitable documentation (see list above) is used to determine the date range for the appropriate fee. For example, if the date on the vehicle registration for a larger passenger vehicle is February 15th it falls between December 1st and March 31st so the prorated fee is \$80. If the applicant provides no documentation, the full fee listed under June 1st through November 30th is charged. <b>The late fee, if applicable, is added to the appropriate fee.</b></p>

Veteran (V) - Disabled Veteran & Prisoner of War - Current license plate number beginning with XP or DV
